1 Description

An AN302 is an Ultra-Wideband (UWB) anchor designed for use with the Ciholas UWB (CUWB) Real-Time Location Systems (RTLS). In a typical CUWB RTLS deployment, the AN302 operates as a static, or anchored, device providing reference points for precise location tracking. The AN302 connects via Ethernet to provide reliable, low-latency, high-bandwidth communications with the rest of the CUWB System.

The AN302 receives UWB pulses from tracked devices and transmits time synchronization data in real time. Anchors are positioned throughout the desired tracking area to enable precise location and data collection. AN302 units are lightweight and easily repositionable allowing for quick setup and teardown. For additional information on deploying a CUWB RTLS using the AN302, see Deployment Considerations.

AN302 anchors feature a built-in multi-port Ethernet switch, support standards-compatible chainable Power over Ethernet (PoE), and Ciholas ChainPoE™ which allows multiple devices to be powered from a single PoE switch port.





The AN302 has a safety or tether loop on the back of the device. This can be used for a safety cable for overhead installations or for earthquake strap.




6 Operation

6.1 Power and Communication

The AN302 is powered and networked via a standards-compatible Power over Ethernet (PoE) connection. To operate the device, connect it to an IEEE 802.3af/at compliant PoE switch.







AN302 with Two Cables

This product requires a PoE standards-compliant power source. Passive power injection is not supported.

Once connected, the AN302 will randomly select an IP address from the Auto-IP 169.254.xy range, checking to see if the address is already in use using the Address Resolution Protocol (ARP). See the Networking Guide for additional information on device chaining and network configurations.

AN302 anchors can only power other CUWB Anchors or compatible Ciholas ChainPoE devices. Do not use an available AN302 port to power a general PoE device.

6.1.1 Ciholas ChainPoE™

- Chains of AN302(s): ChainPoE supports up to 12 anchors on a single chain. Plug a cable from one AN302 to the next AN302 in the chain. The total number of devices in a chain depends on the PoE power budget of the upstream switch.
- Ambidextrous Ethernet Ports: The ports on the AN302 are interchangeable, there is no in or out port.
- Chain Redundancy: For critical applications, Series 300 anchors support optional redundant power and data connections to enhance reliability. These redundancies ensure continuous operation even in the event of a cable failure. The last anchor in a chain, or a standalone anchor, can connect to a secondary PoE switch, a switch stack, or a redundant port on the same switch. If a connection fails, the system will recover after a brief time period. See the Networking Guide for additional information on device chaining and network configurations.

PoE standards and corresponding supported chain lengths, for ChainPoE are as follows:








6.2 Mounting & Placement

AN302 anchors should be distributed throughout the desired tracking area to ensure optimal system performance. The device is designed to operate with the following recommended orientations:







AN302 must be installed using either the AH301 - Mounting Plate or AH302 - Mounting Box. Additional brackets for the plate and box can provide more diverse mounting options.



6.3 Configuration

The AN302 must be used with the CUWB Manager Software Package. For details regarding configuration of AN302(s) in the CUWB Manager, see the CUWB Manager Manual.

6.3.1 Firmware Updates

The AN302 can be updated with new firmware releases by using the CUWB Manager. See Firmware Updates for detailed instructions.

6.4 LED Indication

The AN302 has one tri-color (RGB) LEDs for conveying device state to users. In normal operation under DEVICE MODE, the device state can be determined using the table below:

These settings are overwritten when the CUWB Manager is running a CUWBNet and anchors are in ROLE MODE. To use this feature for installation only, do one of the following:

- 1. Stop any nearby active CUWBNets
- 2. Remove unconfigured tag slots from any nearby CUWBNets
- Set any nearby CUWBNets to use DEVICE MODE for anchors. This will change LED behaviors on the actively running CUWBNets.

[CODE A] - No Power

Please check all cables and switch power. The device is not receiving power.

[CODE B] - Fault

The device has hard faulted or there is no link to the CUWB Manager. Please check the device and cables. If the problem persists, please contact Ciholas for support.

[CODE C] - Interior Node with Outbound Power Delivery

The device is functioning properly and is located in the middle of a chain consisting of three or more devices.

[CODE D] - Bootloader

The device is verifying installed firmware or is in the process of updating device firmware. After a short period the device will boot. If the LED persists, please contact Ciholas for support. DO NOT remove power while the device firmware is being updated.

[CODE E] - Border Node with Outbound Power Delivery

The device is functioning properly and is the first node on a chain of one or more devices. It will power the next node in the chain when it is attached.

[CODE F] - End Node

The device is functioning properly and is the last node on a chain of two or more devices.

[CODE G] - Reclassification

The device is in the process of reclassifying for power from the PoE switch.

[CODE H] - Reserved

This code is reserved for future use.




The LED on the AN302 can be completely disabled. See the CUWB Manager Reference Manual for configuration details.

6.4.1 Error Handling during CUWBNet Operation

The RGB LEDs also convey error states during CUWBNet operation. An error is indicated by a 500 ms red flash followed by a three color sequence.

Error Code Timing Diagram



The following color sequences are used to decode error states:

[CODE 0] - UWB IC Communication Error

This indicates that the AN302 firmware is unable to communicate with the UWB transceiver. To clear this error reset the device by removing and reapplying power. If the problem persists, please contact Ciholas for support.

[CODE 4] - Flash IC Communication Error

This indicates that the AN302 firmware is unable to communicate with the external flash IC. To clear this error reset the device by removing and reapplying power. If the problem persists, please contact Ciholas for support.

[CODE 5] - Ethernet Switch IC communication Error

This indicates that the AN302 firmware is unable to communicate with the Ethernet Switch IC. To clear this error reset the device by removing and reapplying power. If the problem persists, please contact Ciholas for support.

[CODE 32] - Hard Fault

If the problem persists, please contact Ciholas for support.

[CODE 33] - Watchdog

If the problem persists, please contact Ciholas for support.



7 Regulatory Compliance

The regulatory certification of the AN302 is selected at time of purchase. The device must only be used where the regulatory certification allows and must be operated in conformance with the regulatory limitations.

7.0.2 Federal Communications Commission (FCC) - USA

1 General Terms and Conditions of Purchase/Service

These General Terms of Purchase/Service are a legal Agreement between you and Ciholas, Inc. 3 Technology License

Ciholas remains the owner of all titles, rights, and interests in the CUWB Software, CUWB Hardware, and other Ciholas products.

Unless expressly stated otherwise, all Software constitutes original code and is subject to the License. Any use of the Software must be in compliance with the License. You acknowledge that the Software and the underlying ideas or concepts of the services and/or products are valuable intellectual property, and you agree not to, except as expressly authorized and only to the extent applicable by statutory law, attempt (or permit others to attempt) to decipher, decompile, disassemble, modify, or otherwise reverse engineer, or attempt to reconstruct or discover any original code, underlying ideas, algorithms, interoperability of the services, products, and Software by any means. If for any reason the performance of any product is not acceptable, the product may be returned to Ciholas for a refund. Please note: bulk orders are not eligible for the money-back guarantee and cannot be canceled once the order is processed.

Shipping costs and any taxes and/or duties are not refundable and there is a 20% restocking fee for all returns under this policy. To be eligible for a refund, a customer must include an RMA# (see our return process) and dated proof of purchase with the item for return. The cost of the return shipment, including all taxes and duties, is at the buyer's expense. Any product returned not in resalable condition will not be refunded.

9 Limited Warranty

Ciholas warrants that all Ciholas manufactured products, excluding software, will be free from any defect in materials or workmanship for a period of one year. Warranty begins on the date that an item is shipped from Ciholas to the buyer. The warranty is non-transferable and is extended only to the original buyers of this product when the product is used for the purpose for which it was intended. The one-year warranty covers only defects arising under normal use and does not include malfunctions or failures resulting from misuse, abuse, neglect, alteration, improper installation, acts of nature, tampering, or any repairs attempted by anyone other than Ciholas.
